

PARK RULES

(Updated January 2, 2017)

RELEASE FORMS

- A. ALL RIDERS must read and execute the Waiver of Liability and Release Forms prior to participating in any Park activity or using any of the Park facilities, Equipment, or courses.
- B. ALL riders under the age of (18) must have the proper Waiver of Liability and Release Form executed by the rider's Natural Guardian (as defined by Florida Statutes). If you are bringing a minor child, and you are not the Natural Guardian of said child, you must bring a properly executed WAIVER of Liability and Release Form executed by the minor child's Natural Guardian. There will be NO EXCEPTIONS to this requirement.
- C. The mandated Waiver of Liability and Release Forms may be obtained at Hard Labor Creek Off Road Park only. If a child is involved in a shared custody, BOTH parents are REQUIRED to sign a waiver and it MUST be notarized.

SAFETY EQUIPMENT

- (1) ALL RIDERS AND PASSENGERS MUST WEAR DOT APPROVED HELMET.
- (2) WE STRONGLY RECOMMEND YOU WEAR EYE AND FOOT PROTECTION.

PARK RULES

- (1) -- THIS PARK IS ONLY FOR DIRT BIKES.
- (2) -- RIDER AGE --- UNDER 5 MAY NOT RIDE ON OR IN ANY MOVING VEHICLE WITHIN THE PARK WITHOUT EXPRESSED PERMISSION OF THE PARK MANAGER.
 - 5 TO 12 -- UP TO 150 CC
 - 13 TO 16 -- UP TO 250 CC
 - 16 AND OLDER -- 250 CC AND UP
- (3) -- NO WALKING, RUNNING, OR BIKE RIDING ON TRAILS.
- (4) -- ALL TRAILS ARE (1) ONE WAY.
- (5) -- WE HAVE ZERO TOLERANCE FOR DRUGS AND ALCOHOL.
- (6) -- NO GROUND FIRES EXCEPT IN DESIGNATED AREAS.
- (7) -- YOUR DOGS ARE WELCOME; HOWEVER, WE DO HAVE A LEASH RULE.
- (8) -- NO DOUBLE RIDING IS ALLOWED.
- (9) -- SERVICE ROADS ARE 10 MILES PER HOUR AND ARE (2) WAY, AND STAY TO THE RIGHT.
- (10) -- THREE WHEELED VEHICLES ARE NOT ALLOWED.
- (11) -- STAY OFF PRIVATE LAND.
- (12) -- STAY ON TRAILS AND ONLY ENTER AND EXIT WHERE IT IS MARKED TO DO SO
